3 AN ORDINANCE APPROPRIATING MONIES FOR THE PURPOSE OF
4 DEFRAYING THE EXPENSES OF THE SEVERAL DEPARTMENTS OF
5 THE CITY GOVERNMENT OF THE CITY OF FORT WAYNE, INDIANA,
6 FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2023, AND ENDING
7 DECEMBER 31, 2023, INCLUDING ALL OUTSTANDING CLAIMS AND
8 OBLIGATIONS AND FIXING A TIME WHEN THE SAME SHALL TAKE
9 EFFECT.

10 NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
11 THE CITY OF FORT WAYNE, INDIANA:

12 SECTION 1. That for the expenses of the City Government and its
13 institutions for the year ending December 31, 2023, the sums of money shown in the 2023
14 Operating Budget Book are hereby appropriated and ordered set apart out of the several
15 funds herein named and for the purposes herein specified, subject to the laws governing
16 the same. Such sums herein appropriated shall be held to include all expenditures
17 authorized to be made during the year, unless otherwise expressly stipulated and provided
18 by law. Two (2) copies of the 2023 Operating Budget Book are on file and available for
19 public inspection in the office of the Clerk of the City of Fort Wayne, as required by I.C. 36-
20 1-5-4.

21 SECTION 2. That this Ordinance shall be in full force and effect from and
22 after its passage and approval by the Common Council, and any and all necessary
23 approval by the Mayor, legal publication thereof, and is subject to the laws of the State of
24 Indiana governing appropriations.
