Dear Governor Holcomb,

Pursuant to Indiana Code ch. 8-1-1.5, the Indiana Utility Regulatory Commission Nominating Committee is pleased to submit to you this letter certifying our three (3) nominations to fill the vacancy on the Indiana Utility Regulatory Commission (IURC) caused by David Ober's resignation, which took place on June 22, 2022.

The Committee consists of gubernatorial and legislative appointees. In addition to myself, Carol Stephan, as chair, the members of the Committee are Bill Champion, Michael Leppert, Jonathan Mayes, Carolene Mays, and Jim Merritt.

On May 31, 2022, the Committee announced the impending vacancy on the IURC and called for applications to be submitted by June 30, 2022. The Committee received seven (7) applications and, following the withdrawal of two (2) candidates, met on July 27, 2022, in Conference Room 3 of the Indiana Government Center South for the following:

- At 9:00 AM, the Committee convened for an executive session pursuant to Ind. Code § 5-14-1.5-6.1(b)(10) to develop a list of prospective appointees and consider applications;
- At 9:45 AM, the Committee convened a public meeting to interview the five (5) remaining applicants in the following order: Lucas Wilson, Justin Brugger, Christopher Norrick, Marcus Turner, and David Veleta;
- At 2:15 PM, the Committee convened for an executive session pursuant to Ind. Code § 5-14-1.5-6.1(b)(10) to develop a list of prospective appointees and consider applications; and
- At 4:00 PM, the Committee convened a public meeting to take a final action by voting to select three (3) nominees to submit for your consideration pursuant to Ind. Code ch. 8-1-1.5.


At the 4:00 PM public meeting, the Committee conducted a public vote and unanimously concurred to nominate for your consideration:
